(Mandamus – ORS 34.105 - 34.240)

**Comes now**, plaintiff, by and through counsel, who for his Amended Petition for  
Peremptory Writ of Mandamus does allege as follows.

**First Cause of Action  
Mandamus**

**1**

Gordon Leitch is a member of the Republican Party.

**2**

On December 23, 2005, Gordon Leitch delivered his fully executed declaration of candidacy  
for nomination for public office (Governor) to the Secretary of State’s Elections Division, Room  
141, State Capitol, Salem, Oregon. A true copy of the fully executed declaration of candidacy is  
marked “Exhibit 1,” is attached hereto, and by this reference made a part hereof.

**3**

At the same time he delivered his fully executed declaration of candidacy for nomination for

1 public office (Governor) to the Secretary of State, Gordon Leitch delivered five (5), twenty dollar  
2 (\$20.00) United States gold coins as payment in full of the filing fee for Governor.

3 **4**

4 Bill Bradbury is Secretary of State.

5 **5**

6 Pursuant to ORS 249.035, a declaration of candidacy for state office shall be filed with the  
7 Secretary of State.

8 **6**

9 Pursuant to ORS 249.002(10), “state office” includes Governor.

10 **7**

11 Pursuant to OAR 165-002-0025, the location for filing declarations of candidacy for state  
12 office and for paying filing fees for said office is the Elections Division, Room 141, State Capitol,  
13 Salem, Oregon.

14 **8**

15 Pursuant to ORS 249.056(1)(b) the filing fee for Governor is \$100.

16 **9**

17 On December 23, 2005 the Secretary of State’s Elections Division accepted both the  
18 declaration of candidacy and the filing fee provided to it by Gordon Leitch.

19 **10**

20 Shortly after receiving Gordon Leitch’s declaration of candidacy and filing fee, the  
21 Secretary of State’s Elections Division exercised its statutory duty to date and time stamp the  
22 declaration of candidacy. ORS 249.006.

23 **11**

24 Shortly after receiving Gordon Leitch’s declaration of candidacy and filing fee, the  
25 Secretary of State’s Elections Division exercised its statutory duty to register Gordon Leitch as a  
26 candidate for Governor. ORS 254.076.

On or about January 10, 2006, Bill Bradbury acting through his Elections Division Operations Manager, Brenda Bayes, illegally revoked Gordon Leitch’s registration as candidate for Governor.

**13**

On or about January 10, 2006, Bill Bradbury, acting through his Elections Division Operations Manager, Brenda Bayes, notified Gordon Leitch in writing that Mr. Leitch had not delivered acceptable “legal tender” in payment of the required filing fee.

**14**

On or about January 16, 2006, Gordon Leitch demanded in writing that Bill Bradbury re-register Gordon Leitch as candidate for Governor because Gordon Leitch had, in fact and in law, tendered payment of \$100.00 in legal tender to Bill Bradbury’s Elections Division.

**15**

On or about February 2, 2006, Gordon Leitch filed his Petition for Peremptory Writ of Mandamus and Complaint.

**16**

On or about February 6, 2006, Gordon Leitch returned to the Elections Division of the Oregon Secretary of State’s office and tendered \$100.00 in silver coins of the United States of America to the Secretary of State as payment of the filing fee for Governor.

**17**

Shortly after receiving and accepting Gordon Leitch’s tender of \$100.00 in silver coins of the United States of America, Bill Bradbury returned Gordon Leitch to the list of candidates for Governor who will be on the ballot for the May 16, 2006 primary election.

**18**

There are two ways a person can become a candidate for a major political party, filing by declaration and filing by petition. ORS 249.020. Filing by declaration is governed by ORS

1 249.002-249.078; OAR 165-010-0005(1); and 2006 State Candidate’s Manual: Major Political  
2 Party pgs. 6-7. To file by declaration, a candidate for Governor must tender a \$100.00 filing fee to  
3 the Oregon Secretary of State. ORS 249.020(2); ORS 249.056(1)(b); 2006 State Candidate’s  
4 Manual: Major Political Party pg. 7. Filing by petition is governed by ORS 249.002-249.078;  
5 OAR 165-010-0005(1); and 2006 State Candidate’s Manual: Major Political Party pgs. 10-12 and  
6 21-24. To file by petition, a candidate for Governor must tender petitions containing at least 1,000  
7 valid signatures. 2006 State Candidate’s Manual: Major Political Party pg. 24.

8 **18**

9 Each and every Major Party candidate for Governor for the May 16, 2006 primary election  
10 filed by declaration. Attached hereto, marked “Exhibit 2,” and by this reference made a part  
11 hereof, is the Secretary of State’s list of all Major Party candidates for Governor for the May 16,  
12 2006 primary election.

13 **19**

14 Gordon Leitch is the only Major Party candidate for Governor for the May 16, 2006 primary  
15 election who paid the required \$100.00 filing fee by tendering silver coins of the United States of  
16 America to the Secretary of State.

17 **20**

18 United States Constitution Article I, §10, Clause 1 prohibits the State of Oregon from making  
19 “any Thing but gold and silver Coin a Tender in Payment of Debts.”

20 **21**

21 United States Constitution Article I, §10, Clause 1 prohibits the State of Oregon and its  
22 Secretary of State from authorizing or accepting the tender of anything other than gold or silver  
23 coins as payment of the filing fee for the office of Governor of the State of Oregon.

**22**

Gordon Leitch is the only person who has paid the required filing fee for Governor using the only form of payment authorized by United States Constitution Article I, §10, Clause 1, hence Gordon Leitch is the only person who has paid the required filing fee for Governor.

**23**

Since no other Major Party Candidate for Governor has paid the required filing fee for Governor, the Secretary of State is not authorized to list any Major Party Candidate for Governor other than Gordon Leitch on his list of candidates for Governor and he is not authorized to include any Major Party Candidate for Governor other than Gordon Leitch on the ballot for the May 16, 2006 primary election.

**24**

This court may issue a writ of mandamus to compel the performance of an act which the law specially enjoins as a duty resulting from an office. ORS 34.110.

**25**

The writ shall be allowed by this court. On the filing of the order of allowance, the clerk or court administrator forthwith shall issue the writ in accordance with the petition. ORS 34.130(3).

**26**

When the right to require the performance of the act is clear, and it is apparent that no valid excuse can be given for not performing it, a peremptory mandamus shall be allowed in the first instance. ORS 34.160.

**27**

Gordon Leitch is entitled to an award of attorney fees. ORS 34.210.

**Prayer**

On Gordon Leitch’s first claim for action, he prays that the court immediately issue a peremptory writ of mandamus to Bill Bradbury commanding him to immediately remove all candidates other than Gordon Leitch as Major Party Candidates for Governor and to file, not later

1 than the 61<sup>st</sup> day before the date of the primary election, with each county clerk a statement that  
2 Gordon Leitch is the only Major Party Candidate for Governor and an award of costs including  
3 attorney fees.
